## **OMNIBUS MOTIONS**

The following omnibus motions, provided to Session in advance of the meeting, were duly adopted:

- Resolved, that the submitted Session Meeting Minutes August 16, 2022, be approved.
- Resolved, that the submitted Session Meeting Minutes September 24, 2022, be approved.
- Resolved that the Covenant Partner Reports for August and September be approved.
- It is moved by the Governance Committee of the Session that the By-laws of First Presbyterian Church of Houston be amended in Article Four (Nominating Committees), Section 4.2 (Officer Nominating Committee), as well as the corresponding entry in the Table of Contents on page ii, to change the name "Officer Nominating Committee", wherever it occurs in such by-laws, to "Elder Nominating Committee." This proposed change is simply to reduce confusion regarding the meaning of the term "officer" and to recognize that the only office for which this committee nominates members is the office of Ruling Elder.
