### Pastor's Report

#### Rev. Curtis Bronzan

- The schedule for the Vision Team extended to May as Shawn Reilly, the facilitator will miss the March meeting.
- Update from the recruiters for the position of Young Adults and Youth Directors/Pastors. Brian Abbey has interviewed 30 candidates for Young Adults and has 18 potential candidates. There are similar skills in both YA and Youth positions. He has interviewed 27 candidates for the more difficult hiring of a Youth Director. He has 9 potential candidates.
- Jim Singleton is helping with referrals.
- Rick Keltney is interviewing candidates for the Discipleship Pastor position and has a candidate that is interested in talking with Curtis.
- Leo Espinosa reported that the first meeting of the Search Committee will meet next week. Jon Crantz and Lija Shah will be working on transition as Lija leaves.
- Rev. Bronzan proposed having 3 Easter Sunday services instead of the 4 services last year. The children and Contemporary services had similar music and combining them into one will provide a larger and more meaningful experience in the Lancaster Center. The proposed services will be at 8:00 and 11:00 in the sanctuary and 9:30 in Lancaster Center
- Rev. Jon Crantz's request for Sabbatical leave was discussed.
- Housing Allowance policy was discussed. James Melchers, a member of the Finance Committee described the intentions of his mentor and friend, Martin Dunagin, and proposed how the a portion of the remainder of his gift to the church could be used to help finance home loans to potential Pastors/Directors that would need assistance if they accepted positions at FPC.
- Rev.Bronzan revisited the questions from the January Session meeting regarding the Worship schedule. The Session members were broken into three groups to discuss the best answers and after a brief review from their groups, the elders were asked to pray about how to implement and make positive communication about any possible changes.
