  - RESOLVED FURTHER, The Session authorizes signing privileges for the bank accounts to Curtis Bronzan, Senior Pastor, Keith Cole, Treasurer, and Hunter Johnson, Chief Operating Officer.
  - RESOLVED FURTHER, The Session of First Presbyterian Church authorizes signing privileges on the safety deposit box for Hunter Johnson, Chief Operating Officer, and Lisa Belus, Director of Human Resources.
- A motion was made and approved to approve the Resolution for Contractual Obligation Signing Privileges authorizing these privileges to Curtis Bronzan, Senior Pastor and to Hunter Johnson, Chief Operating Officer.
