• March financial condition: Keith reported that March contributions were strong, totaling \$896,000 for the month and nearly \$300,000 above the forecast. Expenses were lower than budgeted, resulting in a net income before investment/depreciation of \$50,000. Year-to-date, FPC is now only \$190,000 below its revenue forecast and ahead of budget on a net income basis of \$260,000. Liquidity continued substantially unchanged and remains adequate for operations.
