- The Finance Committee moves to recommend that the Session vote to approve an expenditure of \$10,681.24 from the Music Equipment Fund to reimburse our operating account for music equipment repairs spent during this past fiscal year.
- The Finance Committee moves to recommend to the Session that they vote to approve an expenditure of \$16,000 from the Music Fund to purchase new choir robes.

• April financial condition: Keith reported that April expenses are under in some areas. \$330k vs \$550k budgeted for the month. Over 1/2 way. Need \$781k to hit budget for the year. Anticipate June attendance to be normally lighter.

• Evelyn Smith shared the established objectives of the Senior Pastor role as well as the accomplishments of Rev. Bronzan over his first year as Senior Pastor of First Presbyterian Church.

### <u>Standing Nominating Committee/Elder Nominating Committee</u> Roby Novell

- The decision to extend the nomination deadline resulted in a great turnout for submissions and a high number of great covenant partner candidates were received to consider for both Elder Class of 2028 and the 2025 Elder Nominating Committee.
- The sixth nominee for the Elder Class of 2027, Jeff Kennedy. is moving to Dubai in August resulting in his inability to serve as an Elder. A **Motion** was made and approved to submit Keith Hickey to fill the sixth position in the Elder Class of 2027, to be voted on by the congregation.

### Pastor's Report

- There are two strong candidates for Young Adult Pastor and one strong candidate for Discipleship Pastor and two candidates for Youth Pastor, more candidates for youth and young adult should be incoming from the recruiter.
- The next Presbytery Meeting will be in San Antonio September 20-21. Three pastors and three session delegates can be sent to the meeting.
- The Session Retreat will be September 27-28 at the Barnes Ranch.
- Changes in the schedule for worship services are still under discussion.
- The Session speaks with one voice.
- The Session Meetings for the 2024-2025 year will move to the 4<sup>th</sup> Tuesday of the month with the exception of November and May which will remain the third Tuesday of the month.

#### TRUEWORKS UPDATE

Doug Meikle presented an update for TrueWorks, how they are doing with fund raising and the number of people going through the program. Memorial Drive Presbyterian is making plans to adopt the program at their church. Doug is accepting a position as CEO at Star of Hope. Rachel Quan will be Executive Director of TrueWorks.
